4. Punctuality and Duration

4.1 If the ceremony begins 30 minutes late, an additional \$50 fee will apply.

4.2 If the ceremony begins over one hour late, it will only take place if the officiant is available, with a \$100 additional fee. If not possible, the ceremony will be canceled without refund.

4.3 It is strongly recommended that all participants and vendors arrive on time.

5. Cancellations and Changes

5.1 Any change of date must be notified in advance to coordinate a new date.

5.2 In case of cancellation by the client, the deposit is non-refundable.

6. Cancellations Due to Force Majeure or Bad Weather

In exceptional circumstances beyond the officiant's control (bad weather, medical emergencies, etc.), the client will be notified as soon as possible and offered a full refund or a professional replacement.

7. Ceremony Rehearsals

Rehearsals have an additional cost depending on distance and time required (price to be determined and negotiated).

8. Travel Expenses

If the event location is more than 48 km from the officiant's headquarters, an additional travel fee will apply, previously negotiated with the client.

9. Symbolic Elements

Symbolic elements used during the ceremony (candles, sand, chests, ribbons, cards, plants, or other objects) must be provided by the client. United Hearts is not responsible for acquiring, customizing, or transporting these items, unless previously agreed in writing with the client, in which case an additional fee will apply.

10. Decoration and Sound Rental

10.1 **United Hearts by Lola does not provide decoration or audio services.**

10.2 The client may rent decorative items such as arches, curtains, flowers, audio, speakers, microphones, etc., by the hour, applying the prices indicated in each package or agreement.

10.3 The client is responsible for any damage or loss of rented items.

11. Add-Ons

11.1 **Wooden Arch Rental** with curtains, cascading flowers, and white artificial flowers: \$100 per hour

12. Sound Service

Includes 2 professional speakers, 1 wireless microphone, basic operation, and audio testing prior to the ceremony. Available only during the ceremony. Price: \$100 per hour

13. Image Rights

United Hearts by Lola reserves the right to use photos or videos of the event for promotional purposes (website, social media, etc.), unless otherwise indicated in writing by the client before the ceremony.
